Recology Helps You Recycle

State law AB 341 requires all public and private businesses that generate four or more cubic yards of waste weekly to recycle. Multi-family housing units of five or more units must recycle—regardless of the amount of waste they generate. Even if you produce less than this amount, recycling is the right thing to do.

The great news is that commercial and multi-family customers of **Recology** in Auburn

are already recycling! The Materials Recovery Facility (MRF) located at 3033 Fiddymont Road in Roseville sorts and recycles the materials we collect.



Commercial Recycling with Recology!

Assembly Bill 341 requires commercial customers and multi-family customers to recycle. The great news in Auburn is that our customers already recycle. Customers in Auburn comply to the law and that helps the environment because recyclables are diverted from going to a landfill.

Where Are My Recycling Bins?

Separate recycling bins are not necessary for **Recology Auburn Placer** customers! The materials in your trash bins are sorted at a Materials Recovery Facility where the recyclable materials are removed and recycled. You may place all materials in your single bin and we will sort it out!

Customers who produce large amounts of recyclables may request separate bins that are used exclusively for these materials. We will provide you with a waste assessment to determine if a separate office paper, cardboard, or green waste bin is right for you.

Available Bins

Recology Auburn Placer has a wide selection of bins and services available for recyclables like green waste, cardboard, office paper, and newspaper. Debris boxes in various sizes are provided for larger projects, construction or demolition projects, or special events.

Construction & Demolition (C&D)

Recology is your approved C&D transporter, offering containers in various sizes and flexible scheduling. All mixed C&D debris box loads are taken to the Materials Recovery Facility to be sorted to maximize diversion.

Common C&D materials include lumber, drywall, metals, masonry (brick, concrete, etc.), carpet, plastic, pipe, rocks, dirt, paper, cardboard, or green waste related to land development. Many of these materials can be reused or recycled, thus prolonging our supply of natural resources and potentially saving money in the process. Of these, metals are the most commonly recycled material while lumber makes up the majority of debris that still goes to a landfill. When you recycle debris from construction and demolition sites, you greatly reduce the impact on our landfills.



There are many bin size and style options for construction and demolition debris, greenwaste, cardboard, office paper, and newspaper.
